

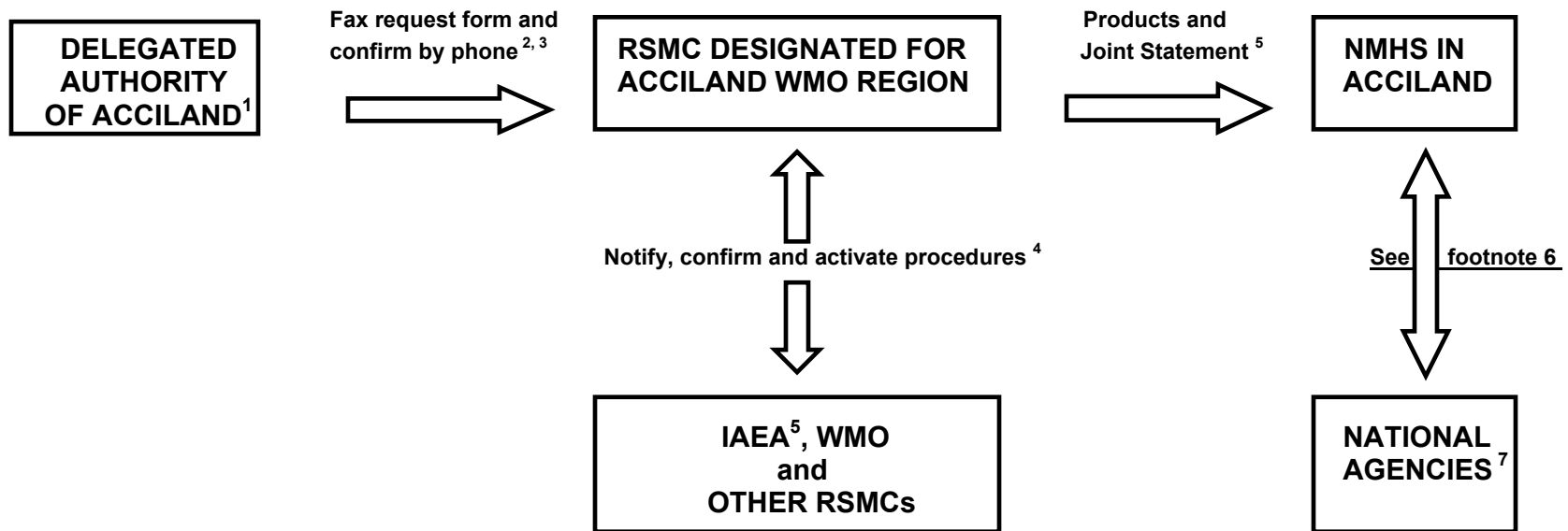
ANNEX 5

FICTITIOUS SCENARIOS TO DEMONSTRATE RSMC SUPPORT FOR ENVIRONMENTAL EMERGENCY RESPONSE

ACCILAND*	Country where a nuclear accident is occurring or about to occur
NEIGHBOURLAND*	Country neighbouring on ACCILAND
DISTANTLAND*	Country at considerable distance from ACCILAND
Scenario 1	ACCILAND learns of the accident and realizes the potential for an uncontrolled release of radioactive material to the atmosphere and needs Atmospheric Transport Modelling (ATM) guidance
Scenario 2	NEIGHBOURLAND learns through the media of a potential accident in ACCILAND and needs Atmospheric Transport Modelling (ATM) guidance
Scenario 3	DISTANTLAND is concerned that an accident in ACCILAND could have impacts on its own country and needs Atmospheric Transport Modelling (ATM) guidance

*It is assumed here that ACCILAND and NEIGHBOURLAND are located in the same WMO Region and that DISTANTLAND is not

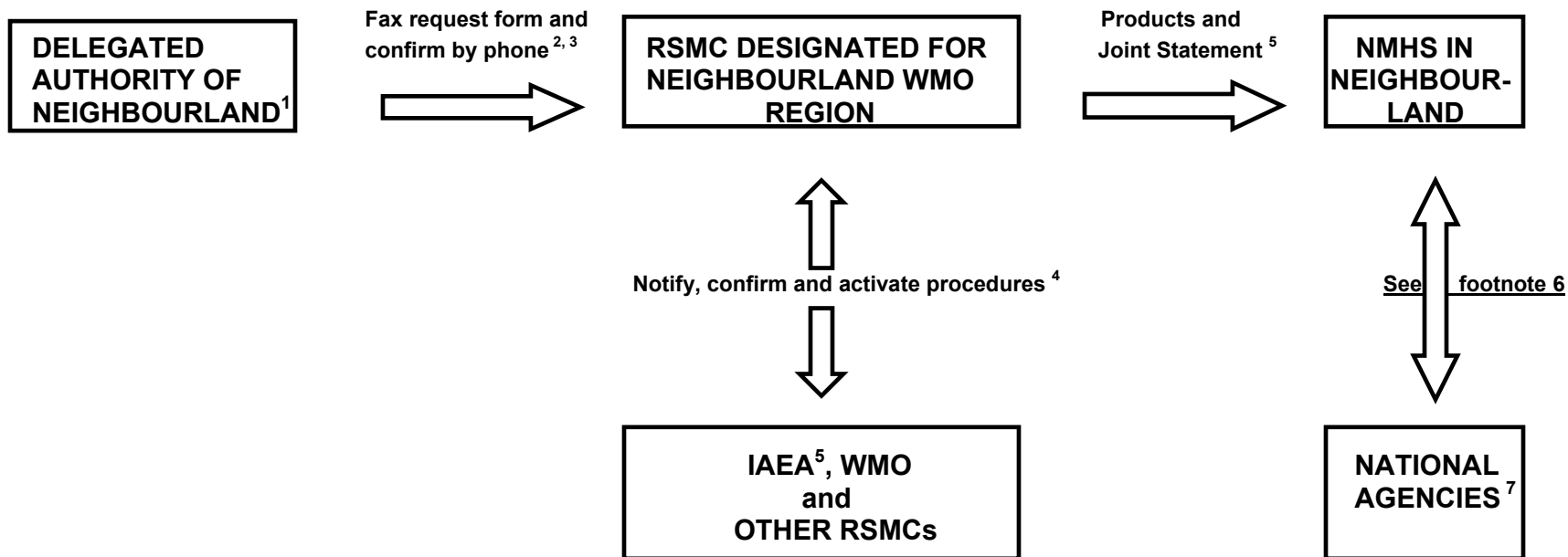

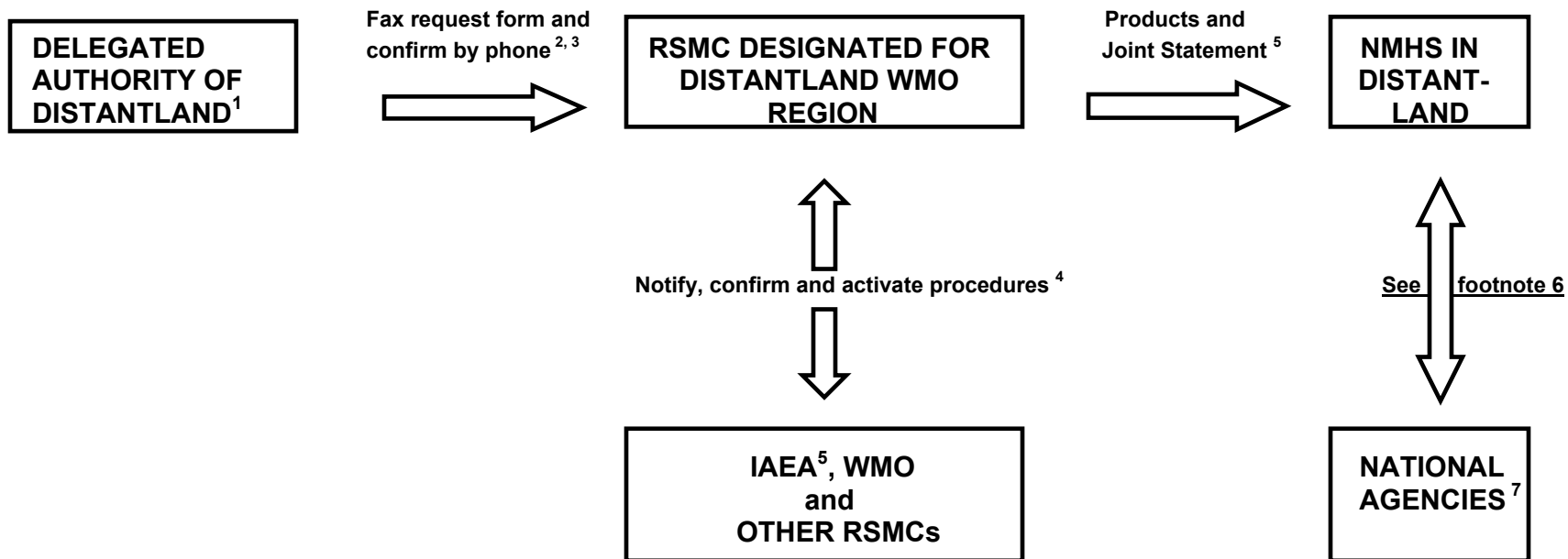
